The specificity of each primer solution of the HLA-B\*46 primer set has been tested against 48 well characterized IHWC cell line DNAs.

No DNAs carrying the alleles to be amplified by primer solutions 2 to 4, 6, 7, 10 to 12, 15, 17, 18 and 20 to 22 were available. The specificities of the primers in primer solutions 3, 4, 6, 10 to 12, 15, 17, 20 and 22 were tested by separately adding one or two additional 5'-primers, respectively one or two additional 3'primers. In primer solutions 2, 7, 18 and 21 it was only possible to test the 5'primer, the 3'-primer was not possible to test.

In primer solutions 4 and 10 one of the 5'-primers was not possible to test, and in primer solutions 6, 8, 12, 13, 15 and 16 one of the 3'-primers was not possible to test. Additional 5'-primers in primer solutions 13 and 15 were tested by separately adding one 3'-primer.
