The specificity of each primer solution of the HLA-B\*82 primer set has been tested against 48 well characterized IHWC cell line DNAs.

No DNAs carrying the alleles to be amplified by primer solution 5 was available. In primer solution 5, it was only possible to test the 5'-primer, the 3'-primer was not possible to test.

In addition, one of the 3'-primers in primer solutions 3 and 4 were tested by adding an additional 5'-primer.

**Results:** No false positive or false negative amplifications were obtained.
