INTERPRETATION

The interpretation of DRB1*07 PCR-SSP subtypings will only be influenced the DRB1*09:08 allele, when present on the other haplotype. Thus, the interpretation of DRB1*07 subtypings is only marginally influenced by other groups of DRB1 alleles.

UNIQUELY IDENTIFIED ALLELES

All the DRB1*07 alleles², i.e. **DRB1*07:01 to DRB1*07:19**, recognized by the HLA Nomenclature Committee in July 2010¹ will give rise to unique amplification patterns by the primers in the DRB1*07 subtyping kit.

The DRB1*07 subtyping kit cannot distinguish the DRB1*07:01:01:01 to DRB1*07:01:03 alleles.

RESOLUTION IN HOMO- AND HETEROZYGOTES

A total of 20 alleles generate 17 amplification patterns that can be combined in 153 homozygous and heterozygous combinations. 101 of these genotypes do not give rise to unique amplification patterns. The different sizes of the specific PCR products generated by primer mixes 4 and 5 have not been considered in this calculation.

When the primers in a primer mix can give rise to specific PCR products of more than one length this is indicated if the size difference is 20 base pairs or more. Size differences shorter than 20 base pairs are not given. For high resolution SSP kits the respective lengths of the specific PCR product(s) of the alleles amplified by these primer mixes are given.

Nonspecific amplifications, i.e. a ladder or a smear of bands, may sometimes be seen. GC-rich primers have a higher tendency of giving rise to nonspecific amplifications than other primers.

PCR fragments longer than the control bands may sometimes be observed. Such bands should be disregarded and do not influence the interpretation of the SSP typings.

PCR fragments migrating faster than the control bands, but slower than a 400 bp fragment may be seen in some gel read-outs. Such bands can be disregarded and do not influence the interpretation of the SSP typings.

No DNAs carrying the alleles to be amplified by primer solutions 3 to 15 were available. The specificities of the primers in primer solutions 4, 5, 6 and 9 were tested by separately adding one additional 5'-primer, respectively one additional 3'-primer. In primer solutions 3, 8, 12 and 13 it was only possible to test the 3'-primers, the 5'-primers were not possible to test.
