## PRODUCT DESCRIPTION

### HLA-A\*25 SSP subtyping

#### CONTENT

The primer set contains 5'- and 3'-primers for identifying the A\*2501 to A\*2508 alleles.

#### PLATE LAYOUT

Each test consists of 10 PCR reactions in a 16 well cut PCR plate. Wells 11 to 16 are empty.

The 16 well PCR plate is marked with 'HLA-A\*25' in silver/gray ink.

Well No. 1 is marked with the Lot No. '20G'.

A faint row of numbers is seen between wells 1 and 2 or wells 7 and 8 of the PCR trays. These stem from the manufacture of the trays, and should be disregarded.

The PCR plates are heat-sealed with a PCR-compatible foil.

**Please note:** When removing each 16 well PCR plate, make sure that the remaining plates stay sealed. Use a scalpel or a similar instrument to carefully cut the foil between the plates.

#### INTERPRETATION

The interpretation of HLA-A\*25 SSP subtypings will be influenced by most A\*01, eleven A\*02, two A\*03, most A\*11, the A\*2313, four A\*24, the A\*26, two A\*31, most A\*32, the A\*3313, the A\*34, the A\*36, the A\*4301, most A\*66, most A\*68, the A\*6901, the A\*7410 and the A\*8001 allele when present on the other haplotype.

#### UNIQUELY IDENTIFIED ALLELES

All the HLA-A\*25 alleles, i.e. **A\*2501 to A\*2508**, recognized by the HLA Nomenclature Committee in July 2009<sup>1</sup> will give rise to unique amplification patterns by the primers in the HLA-A\*25 subtyping kit.

The HLA-A\*25 subtyping kit cannot distinguish the A\*250101 and A\*250102 alleles.

#### RESOLUTION IN HOMO- AND HETEROZYGOTES

The 8 HLA-A\*25 alleles can be combined in 36 homozygous and heterozygous combinations. Twenty-two of these genotypes do not give rise to unique amplification patterns. The different sizes of the specific PCR products generated by primer mix 7 were not considered in these calculations.

<sup>1</sup>Alleles are assigned by the presence of specific PCR product(s). However, the sizes of the specific PCR products may be helpful in the interpretation of HLA-A\*25 SSP typings.

When the primers in a primer mix can give rise to specific PCR products of more than one length this is indicated if the size difference is 20 base pairs or more. Size differences shorter than 20 base pairs are not given. For high resolution SSP kits the respective lengths of the specific PCR product(s) of the alleles amplified by these primer mixes are given.

Nonspecific amplifications, i.e. a ladder or a smear of bands, may sometimes be seen. GC-rich primers have a higher tendency of giving rise to nonspecific amplifications than other primers.

PCR fragments longer than the control bands may sometimes be observed. Such bands should be disregarded and do not influence the interpretation of the SSP typings.

PCR fragments migrating faster than the control bands, but slower than a 400 bp fragment may be seen in some gel read-outs. Such bands can be disregarded and do not influence the interpretation of the SSP typings.

Some primers may give rise to primer oligomer artifacts. Sometimes this phenomenon is an inherent feature of the primer pair(s) of a primer mix. More often it is due to other factors such as too low amount of DNA in the PCR reactions, taking too long time in setting up the PCR reactions, working at elevated room temperature or using thermal cyclers that are not pre-heated.

<sup>2</sup>The internal positive control primer pairs amplify segments of the human growth hormone gene. The two different control primer pairs give rise to either an internal positive control band of 1070 base pairs, for most wells, or a band of 800 base pairs, for some wells.

Well number 1 contains the primer pair giving rise to the shorter, 800 bp, internal positive control band in order to help in the correct orientation of the HLA-A\*25 subtyping.

In addition, wells number 2, 3, 4 and 7 contain the primer pair giving rise to the shorter, 800 bp, internal positive control band in order to allow kit identification.

In the presence of a specific amplification the intensity of the control band often decreases.

<sup>3</sup>Due to the sharing of sequence motifs between HLA-A alleles non-HLA-A\*25 alleles will be amplified by the A\*25 primer mixes 1 to 7.

<sup>4</sup>Specific PCR fragments shorter than 125 base pairs have a lower intensity and are less sharp than longer PCR bands.

The specificity of each primer solution of the kit has been tested against 48 well characterized IHWC cell line DNAs.

No DNAs carrying the alleles to be amplified by primer solutions 6 and 8 to 10 were available. The specificities of the primers in primer solutions 6 and 8 were tested by separately adding one additional 5'-primer, respectively one additional 3'-primer. In primer solution 9 it was only possible to test the 5'-primer, the 3'-primer was not possible to test. In primer solution 10 it was only possible to test the 3'-primer, the 5'-primer was not possible to test. An additional 3'-primer in primer solution 7 was tested by separately adding one additional 3'-primer.

**Results:** No false positive or false negative amplifications were obtained.
