The primer set contains 5'- and 3'-primers for separating the HLA-B\*39:01:02:01L from the B\*39:01 alleles.

#### PLATE LAYOUT

Each test consists of 2 PCR reactions in an 8 well cut PCR plate. Wells 3 to 8 are empty.
