PRODUCT DESCRIPTION

HLA-C*08 Add-on SSP subtyping

CONTENT

The primer set contains 5'- and 3'-primers for distinguishing the HLA-C*08:22 alleles from the C*08:01 allele.

PLATE LAYOUT

Each test consists of 2 PCR reactions in an 8 well cut PCR plate. Wells 3 to 8 are empty.

The 8 well cut PCR plate is marked with the Lot No. '45S' in silver/gray ink.

Well No. 1 is marked with the Lot No. '45S'.

A faint row of numbers is seen between wells 1 and 2 or wells 7 and 8 of the PCR trays. These stem from the manufacture of the trays, and should be disregarded.

The PCR plates are heat-sealed with a PCR-compatible foil.

Please note: When removing each 8 well PCR plate, make sure that the remaining plates stay sealed. Use a scalpel or a similar instrument to carefully cut the foil between the plates.

INTERPRETATION

The interpretation of HLA-C*08 Add-on SSP subtypings will be influenced by most other C*08 alleles. In addition, the C*05:79 allele will be amplified by primer mix 1 and the C*15:29 allele will be amplified by primer mix 2.

UNIQUELY IDENTIFIED ALLELES

The HLA-C*08:01¹, and 08:22 alleles give different patterns in the HLA-C*08 Add-on kit².

¹The HLA-C*08 Add-on kit cannot distinguish the silent mutations in the C*08:01:01-08:01:09 alleles.

Nonspecific amplifications, i.e. a ladder or a smear of bands, may sometimes be seen. GC-rich primers have a higher tendency of giving rise to nonspecific amplifications than other primers.

PCR fragments longer than the control bands may sometimes be observed. Such bands should be disregarded and do not influence the interpretation of the SSP typings.

PCR fragments migrating faster than the control bands, but slower than a 400 bp fragment may be seen in some gel read-outs. Such bands can be disregarded and do not influence the interpretation of the SSP typings.

Some primers may give rise to primer oligomer artifacts. Sometimes this phenomenon is an inherit feature of the primer pair(s) of a primer mix. More often it is due to other factors such as too low amount of DNA in the PCR reactions, taking too long time in setting up the PCR reactions, working at elevated room temperature or using thermal cyclers that are not pre-heated.

⁴Due to the sharing of sequence motifs between HLA-C alleles most C*08 allele will be amplified by primer mix 1. In addition, the C*05:79 allele will be amplified by primer mix 1 and the C*15:29 allele will be amplified by primer mix 2.

⁵HLA-specific PCR products shorter than 125 base pairs have a lower intensity and are less sharp than longer PCR products.
